Shruti clarified that it is indeed an international summit and that faculty members from all over the world are invited.
- 5. Following Up from past meetings:
 - a. Croatia and Japan conferences: The Croatia conference information is now on the WGI website. John asked for a report at every meeting about how that is going. Janet and Shruti still have not been included in any planning for the conference. Fumiko reported that the dates and theme are set (they are at the bottom of every "minutes" document).
 - b. Denzyl's Request: Denzyl is looking to get information about how different MOs got formed through WGI. He is doing a study about organization for his paper. He sent an email to all the MOs. At the last board meeting there were questions about his research. Kim emailed him these questions but didn't get an answer from him. Kim would like for him to go ahead with the project and would like to know if the board is ok with this.
- 6. Brian Lennon's books: Brian sent an announcement of his "Choice Theory in Action" series. Is this something we want to list on our website and send out a note to the membership? If we are an affiliate with Amazon, we would actually get a percentage every time a book is sold on Amazon. Kim's question for the group is: is it ok to put

There was discussion about whether this was going to be a consultation document or a final document. The board talked about extending the document until the end of August and Kim and Shruti said that deadline is doable for them as well, as the reviewers of the document.

Nancy moved that each committee that is working on something for the consultation document should have something in writing, in a rough draft form, sent to Kim and Shruti by August 18th. The executive committee will review and then distribute this document to the other board members one week before the August board meeting. Kalika seconds the motion.
