> Attorneys: Nancy has spoken to several different firms. One of them got back to her and wanted to make sure there was no conflict of interest. They have firms all over the country. The cost is \$1000 retainer and \$250 an hour. The name of the firm Bell, Davis, and Pitt. The name of the attorney is Kristan Brian and his division is business and non-profit law. He wants the bylaws, the 990 (non-profit tax application), and data that will give him information that will help him determine if there has been a conflict of interest. Shruti shared the document that John sent her about Kim's employment.

Motion: It is moved by Jae and seconded by Farida that William Glasser International, Inc. engage the firm of Bell, Davis, and Pitt, namely Kristan D. Bryant and Galen Craun to investigate the allegations made by Carleen Glasser and signees regarding the 501c3 non-profit status and look at all the questions raised in the letter.
