### 2. Think, pair, share:

  - i. Follow the present guidelines. They probably need to be revisited.
  - ii. One who has its own constitution
  - iii. Registered according to the laws of its own country (they are legal)
  - iv. They write a letter of intent where we state the guidelines that they follow
  - v. Guidelines where they are going to need to put into place a formal way to collect dues. (For example, Canada collects dues for several countries currently).
  - vi. These guidelines be translated in their own individual language (each MO would do this)

Value and ethical beliefs around money-it costs us money to take money out of our investments. We have been taking money aside so we are not taking it out every month.

a. The board discussed the proposed umbrella organization ideas with the MOs. The MOs were asked for suggestions and about any concerns they might have. Farida

- said at this point it sounds good and eventually people might just wonder about how this might benefit the MOs and their organizations.
- b. The board updated the MOs on the financial situation. The board has come out of survival mode. There may be some investment opportunities. WGI will be ethically conscious about where to invest (no investment in guns, drugs, etc).
- c. The board let the MOs know that instead of a \$20/person fee, we are thinking about moving to a percentage payment. So for example, Japan would pay a percentage of all their income to WGI instead of \$20/member that belongs to WGI-Japan. Some of the MOs said they preferred having a choice of a dollar amount or a percentage. To clarify, this would be a percentage of all income, trainings, etc. The idea is to simplify how people pay.
- d. How do we elect MO reps? Do the MOs have their own process that they use in their own countries? Some countries have a process in place. WGI has the use of surveymonkey.com where members can vote. Canada, US, India, Japan, Australia all have processes in place. India would lie to use surveymonkey.com.
- e. How would we elect to the WGI executive board? Do we have a chair or president? Fumiko suggested keeping the executive board as it is for a year or two or three so that there can be a smoother transition.
- f. The hope is that the executive committee will meet in person at least once a year and possible more since meeting in person really helps us understand perspectives and work together.
- g. Stages of membership were discussed. The MOs asked that this be typed up and sent to them so it's easier to process. The board said they would put a packet together that will include everything we talked about. This will be just a draft so that MOs could give their feedback.
- h. Janet spoke about the research committee. Kim suggested an email address for research that would be research@wglasserinternational.org
- i. Nancy spoke about the program committee. There are 84 people attending the Take Charge day in Bogota today. Nancy is collecting research on this. Jean and Nancy have also worked on a communication skills course that will teach people how to deal with difficult situations. The course is available for instructors to teach. The Take Charge of Your Life program was also discussed and questions were answered. Farida brought up a concern of having certificates being sent via email and not hard copy to hand out the day of the program. Kim suggested that every MO give out their own certificate in the interim until the WGI certificates get to them.
- j. How can we best communicate? Farida asked for updates when the website is updated so that people don't have to keep checking the website. Farida also talked about the concern of MOs not knowing that their members have been acknowledged as a member.

    - ii. Attend a face to face meeting 2019 to complete and merge tasks and to consider other needs of the organization under construction.
  - b. WGI will call elections from Established and Intermediate MO's at the optimum time, when constitutional documents have been created.
  - c. WGI will announce/confirm the "Umbrella Organization Members". Those attending in Croatia and those able to attend online may meet and elect the "Umbrella" board executive.

    - i. They want to make sure they have communication from us. Mitchell said he hasn't received any communication in over a year
    - ii. They are concerned about numbers in the umbrella (1-22)
    - iii. They want information on what's being worked on
    - iv. They want more faculty training in accessible places
    - v. They want to see a bank of instructors that are willing to go to other countries. They also want a list of people who will fly there on their own dime and they would cover the accommodations. There would be no fee.
    - vi. They asked for transparency when it comes to money and procedures
    - vii. Nancy will get back to them about their concerns.
    - viii. Shruti will look into having the board meeting in South Africa. Would they be ok with this? Is there a particular time that would work better for them?
  - d. The USA asked why WGI would want to move out of the USA. Kim told them it's so that bylaws would be in line with the practices and because there is concern about being associated with a country run by Donald Trump. The concerns with changing the country of incorporation is that it will be expensive to change. Also, if there is no tax break, who will give donations? In the USA if you donate to WGI, the person gets a tax break.

- 21. Bette Blanch told John she is really happy to see the progress the board is making.
- 22. David from Canada suggested doing faculty training online.
